NOTES ON THE BIBLIOGRAPHY OF INDUSTRIAL BRISTOL

A problem facing all newcomers to industrial archaeology is to discover what reference material is available on the particular topic they wish to study. This material falls into two categories. The first, but not covered in this paper, is the technical literature on how the industry or trade was carried out. The second category deals with the development and history of the industry in the Bristol region, and this paper discusses this type of material and its location.

In researching into the history of the industry of the region, the industrial archaeologist is particularly unfortunate in that the geographical area he is concerned with includes parts of two counties, as well as the cities of Bristol and Bath. This means that archival material relating to a particular industry could be found in any of three record offices, and he will need to become familiar with the stocks of several reference libraries as well.

ARCHIVES

Bristol The Bristol Archive Office, The Council House, College Green, Bristol 1. Archivest: Miss E. Ralph, M.A., F.S.A. Records held here likely to be of interest to the industrial archaeologist are the deeds of all Corporation-owned property, which would include much of the industrial core of the redeveloped city. The tithe maps of the 1840's for the Bristol diocese give exact details of land ownership for this time. The records of some companies are also deposited here, such as the Great Western Cotton factory at Barton Hill, and many papers relating to the Bristol Coalfield. An evening class is arranged each winter in which practice can be gained in using archives, and the office is open during office hours and Saturday mornings for research. A guide is shortly to be published, but detailed catalogues» and indexes are available in the office.

The Bristol Reference Library, Deanery Road, Bristol 1 also has collections of papers of interest to the industrial archaeologist. Among these are the Ellacombe . papers relating to Kingswood, Bitton, Mangotsfield and the Sanigar papers relating to Barton Hill and St. George.

Gloucestershire The County Records Office, The Shire Hall, Gloucester. Records Officer: Brian Smith, M.A. Records similar to those at Bristol are held here, but relating to the county. Many parish records are deposited here, as well as family and business papers. A guide was published in 1958, and details of the more prominent accessions appear in the annual volumes of the Transactions of the Bristol and Gloucestershire Archaeological Society.

Other records, including the archives of the Gloucester diocese are held in the Gloucester City Library, Brunswick Road, Gloucester.

Somerset The Somerset Record Office, Obridge Road, Taunton. County Archivest: I.P.Collis, F.S.A. Records similar to those held in the Bristol and Gloucestershire Record Offices are held here. A guide was published in 1959 and annual additions are published in Proceedings of the Somerset Archaeological and Natural History Society

Other records are held at the Victoria Art Gallery and the municipal libraries, Bath.

London The Public Record Office, Chancery Lane, W.C.2. The records of the Crown and of central government are kept here. A Guide to the Public Records has been published, Volumes 1 and 2, 1963, and Volume 3, 1969.

The National Register of Archives, Quality House,. Quality Court, Chancery Lane, London W.C.2, is a part of the Historical Manuscripts Commission. Since 1964 the Commission has published an annual list of Sources of Business History in the National Register of Archives. This covers the whole country, but a code makes possible the location of local material. It is planned to publish a classified cumulation of the first five lists.

Company Archives Many companies maintain archives of historical interest which are of value to the industrial archaeologist. However, much was destroyed in the last war, both by bombing and in the scrap drive. It never does any harm to enquire if anything has survived, but many firms of some age are unable to. show anything more than a few decades old. Thereis no index to this material, but it is hoped that BIAS can make it a research project in the not too distant future.
